The Lynchburg City Schools' Special Education Advisory Committee (SEAC) is responsible to: advise the local school division of the needs in the education of children with disabilities; participate in the development of priorities and strategies for meeting the identified needs of children with disabilities; submit periodic reports and recommendations regarding the education of children with disabilities; submit periodic reports and recommendations regarding the community or meeting the educational needs of children with disabilities; review policies and procedures for the provision of special education and related services prior to the submission to the local school board; and participate in the review of the local school division's annual plan.

The following are the 2018-19 recommendations from the LCS SEAC Committee:

- Inclusive practices The LCS SEAC recommends that Lynchburg City Schools continue to implement and develop inclusive practices for all students with disabilities. (Focus: Access to the general education curriculum.)
- Disability awareness The LCS SEAC recommends Lynchburg City Schools conduct an annual disability awareness program in October.
- Professional Development The LCS SEAC recommends the Department for Special Education provide the following professional development:
- Registered Behavior Technician (RBT) training for the LCS instructional assistants assigned to division-wide programs;
- Awareness of the unique needs of students considered "Twice Exceptional" (Gifted and Disabled);
- Effective strategies for students with skills deficits in the area of Executive Functioning;
- Best practices in remedial reading instruction including Orton Gillingham reading strategies;
- Instructional strategies for students with emotional disabilities;
- Dyslexia diagnosis and evidence-based instructional strategies;
- Instructional support strategies for students with Autism Spectrum Disorder (ASD); and
- Implementation of research-based behavior management programming for students considered in need of a "Tier III intervention"; and
- Assistive Technology-Aim-Va.
- Extracurricular Support The LCS SEAC recommends LCS IEP committee leads receive awareness training on how to provide access to extracurricular activities for students with disabilities.

- Reading The LCS SEAC recommends the review of the special education supplemental reading programs and determine if additional materials are needed to meet individual student needs. (Example: FUSION) FUSION – https://www.mheducation.com/prek-12/program/fusion-reading2012/MKTSP- QOS01M0.html
- Decentralizing Middle Schools The LCS SEAC recommends Lynchburg City Schools conduct a review of all division-wide programs, including projected enrollment, to determine the possibility of educating students with disabilities in their home schools without the use of division-wide classrooms.
- Transportation –The LCS SEAC endorses the provision of on-going professional development for LCS transportation staff in the area of Autism Spectrum Disorders.

1-3. High School Program of Studies

Each year the school board reviews and approves the High School Program of Studies for the next school year. A team made up of high school administrators, counseling directors, and various members of the departments of special education, student services, and curriculum and instruction have met over the past four months to update this handbook.

The team worked to ensure this handbook includes graduation information consistent with current Virginia Department of Education requirements. The main updates made to this year's handbook include new courses in study skills, computer science, physical education, hip hop, and engineering. It also includes clarity on testing requirements, class rank, sequential electives, and offerings at the Central Virginia Governor's School and the Governor's STEM Academy.

The High School Program of Studies has been posted on the main LCS website for one month to gather input from the public. High school counseling departments have also gathered input from school stakeholders regarding the program offerings at each school.

High school counseling departments will use the 2019-20 Program of Studies to begin meeting with parents and scheduling students in January and February.

J-1. Middle School Program of Studies: 2019-20

Each year the school board reviews and approves the Middle School Program of Studies for the next school year. A team made up of middle school administrators, counseling directors, and various members of the departments of special education, student services, and curriculum and instruction have met over the past three months to update this handbook.

The team worked to ensure this handbook includes course offerings consistent with current Virginia Department of Education requirements. The main updates made to this year's handbook include a revised math sequencing chart and updated information on gifted services, special education, and remediation opportunities. It also includes clarity on math placement and courses offered for high school credit, including the addition of a full high school credit for the Introduction to Theatre course.

Middle school counseling departments will use the 2019-20 Program of Studies to begin meeting with parents and scheduling students in February and March.

The capital improvement plan includes \$60,000 in construction funding for replacement of the William Marvin Bass Elementary School gymnasium floor. The City of Lynchburg Office of Procurement and Purchasing has received bids on the project.

Two bids for the Bass gym floor replacement project were received. The school administration recommends Miller Flooring based on their bid of \$60,185 which was the lowest bid and a unit price of \$7.00 per square foot to replace the subflooring. All bids received are listed below.
