#### F. Student Representative Comments

Mr. Joshua K. Graham, student representative for E. C. Glass High School, and Mr. Robert W. Jones, student representative for Heritage High School, provided information about events and activities occurring at their schools.

#### G-1. School Operating Budget: 2010-11

The school administration has proposed that students be charged a fee to play in middle school athletics. The school board requested information about the number of students participating in middle school athletics, the most popular sports, and a breakdown by sport with the number of players. Mr. Coleman provided some information about the number of middle school students who participated in sports in 2007-08. During that school year, 1,859 students participated in sports. Middle school sports include football, cross country, volleyball, basketball, wrestling, tennis, track, and soccer. The school board also asked for information regarding students in extra-curricular activities that do not have pay a fee for participation.

The school administration provided the information to the school board about elementary school facilities utilization that included enrollment data and staffing information. Staffing at the elementary level cannot be based upon total enrollment as students are not distributed equally among school and grade. Maximum class sizes are established by the Standards of Quality, and the school division receives additional funding from the Virginia Department of Education through the K-3 Class Size Initiative. Class size for students in Kindergarten through third grade is determined by the percentage of free and reduced lunch at each school. Maximum class sizes range from 19 to 24 per class.

A review of the proposed calendar for 2010-11 was provided by the school administration along with current survey results regarding the proposed calendar. While the majority of the respondents, 81 percent, are in favor of the calendar, there were a few comments regarding the length of the school day for younger students.

At the high school level, the elimination of the optional first period bus runs will save transportation costs as all high school students will begin school at 7:40 a.m. Further, the first semester ends prior to winter break, and no exams will be administered to students. Teachers will have the opportunity to administer cumulative tests during class.

High school students will have more opportunities to participate in electives and pursue an Advanced Studies Diploma, and credit recovery courses will be available during the typical school day. This will eliminate the need for summer school for high school students. Study halls will provide additional opportunities for academic support.

At the middle school level, students will have more instructional time in each course, and no concerns have been raised relative to the later ending of the school day.

# G-2. School Board Policy 5-18: Reduction in Force

As a result of discussions by the school board regarding the school division's policy for reduction in force, the school administration has made revisions to the policy. During this presentation, the school administration reviewed the policy with the school board. Those revisions include credit for part-time service, classification of teacher assistant positions, destaffing procedures for employees who are on a plan of assistance, and recall procedures.

#### H-1. School Calendar: 2009-10

The reason for this request is because the Lynchburg City Council election is scheduled for that date, and several schools are used as polling places during elections.
