B. Discussion of School Operating Budget for 2012-13

Due to the 10 extra cuts in staffing, class sizes have increased. If more cuts are made, class sizes will be at a place that where instruction of students will be affected. The school division needs \$3.7 million so that further cuts in staffing will not damage the educational process.

The savings in maintenance and custodial amounts to approximately \$500,000 and can be realized through reduction in force, reconstituting the program and administering ourselves, outsourcing both services or combining efforts with the city. Reductions in force will occur in maintenance and custodial staff in order to obtain the \$500,000 in savings.

The school administration continues to discuss options for the school operating budget for next year because state funding is still unknown. It might be necessary to cut more staff depending on funding from the state and the city. The school administration has met with principals to solicit input regarding staffing, and over \$300,000 has been cut from department budgets.

Budgets for instructional supplies have been increased a small amount, and the school administration hopes to keep that funding intact. Funding was based on what has been spent over the past three years and budgeted accordingly.

The VRS rate has been set at 11:33 percent, and a five percent increase will be given to all employees to cover their payment. The school administration will also need to assume funding for the FICA and group life insurance costs associated with this increase.

The school administration has also made cuts in administration so that staffing cuts at the school level will not be as severe.

Upon MOTION by Rev. Anderson, SECONDED by Mr. Billingsly, the school board approved the school operating budget for 2012-13 as proposed.
