D. Student Representative Comments

Mr. Joshua K. Graham, student representative for E. C. Glass High School, and Mr. Robert W. Jones, student representative for Heritage High School, provided information about events and activities occurring at their schools.

E-1. School Operating Budget: 2010-11

At the March 23, 2010, school board meeting, the Lynchburg City School Board approved the 2010-11 budget with the understanding that the employee benefit section may change, depending on information received concerning charging employees for Virginia Retirement System (VRS). The budget presented included requiring employees to pay seven percent of their health insurance benefit. The school board requested that the school administration inquire about transferring a portion of member contributions to employees for VRS retirement instead of health insurance.

The Virginia Retirement System forwarded the following information to the school administration. House Bill (HB) 1189 was passed by the Virginia General Assembly on March 14, 2010. This bill requires employers to charge new employees (July 1, 2010) five percent of the VRS retirement. The school board will have the option to pass a resolution to pick up this five percent or a portion of the five percent. This bill was passed as a "law" and becomes permanent.

HB 30 (Budget Bill) also was passed by the General Assembly on March 14, 2010. This bill allows employers to pass from one to five percent of the VRS retirement cost to existing employees. This bill was passed as a "budget bill" and can change from year to year unless the General Assembly decides to make it a "law."

During the meeting, Ms. Padgett shared an article from the *Richmond Times-Dispatch* indicating that Governor McDonnell will strike language in the adopted state budget that would allow local governments to shift a portion of the retirement expense for teachers, sheriff's deputies, police officers and other public employees. Therefore, the school administration is unable to have employees pay a portion of the VRS contribution rather than health insurance.

F-1. Administrative Regulation 6-8: School Day

On March 23, 2010, the school board approved the Lynchburg City Schools academic calendar for 2010-11. The approved calendar included the removal of the optional first period bus runs and the reduction in student instructional days from 180 to 172.

In order to account for the fewer number of instructional days, additional instructional time is recommended at each level. Administrative Regulation 6-8: School Day has been modified to reflect these changes.

F-2. Administrative Regulation 6-18: Instruction

Given that a listing of curriculum guides would need frequent revision to stay up to date, and given that there is no requirement to maintain such a listing in policy or regulation, the school administration recommends the deletion of Administrative Regulation 6-18: Instruction.

F-3. School Board Policy 7-24: Student Course Load

On March 23, 2010, the school board approved the Lynchburg City Schools academic calendar for 2010-11. The approved academic calendar includes the following changes:

- 1) the replacement of the optional first-period with a seven-period high school day
- 2) the removal of the current high school exam structure
- 3) the addition of study halls and repeat courses in high school
- 4) the addition of a senior early dismissal option
- 5) the addition of elementary early dismissal days at the end of each six weeks
- 6) the removal of seven work and professional development days
- 7) the lengthening of the winter break
- 8) a spring break the week prior to Easter
- 9) an earlier last day of instruction, May 27, 2011
- 10) graduation in the afternoon on Sunday, May 29, 2011

Given the addition of a senior early dismissal option (item four) the school administration recommends revisions to School Board Policy 7-24: Student Course Load.

Mrs. Tweedy requested information about how 12-month employees would be affected by the school calendar for 2010-11. Dr. McKendrick explained that employee compensation will not be negatively affected by the calendar and the number of days that the school division will be closed for students and staff.

Rev. Anderson commended the administrative staff and faculty for being patient during the budget process. He also extended his prayers to those families who will be affected by the employee reductions.
