E-1. Middle School Security Administrative Assistant

In late spring the Lynchburg City Police Department informed the superintendent that in school year 2011-12 the police department would not provide school resource officers for the school division's middle schools. The school administration then proposed to the school board that it approve the addition of a new position, middle school security administrative assistant, with one placed in each middle school.

At an earlier school board meeting, the school administration presented a draft of a job description to the school board. School board members asked that the school administration return with a final draft, one that would include compensation, contract days, and job tasks. School board members also wanted the position to be one that asks that the staffer would not only resolve and be skilled at keeping the campus secure but also be able to be proactive in an effort to deter and/or prevent incidents from occurring.

The school administration presented a revised job description to the school board. The statements in bold represent the additional tasks/responsibilities that the school board had requested.

The school administration stated that there are similar positions in other school division that provide support for administrative teams at the middle school level. School board members were concerned that there be consistent police presence at the schools. Mr. Coleman stated that the school administration would meet with representatives from the police department to discuss this topic.

E-2. Capital Improvement Plan: Heritage High School

During the school board meeting on June 21, 2011, the school administration presented information to the school board that would allow the curtain wall project to be completed in its entirety using funds from the following sources:

•	Total needed	\$577,980.00

•	Project balance	\$350,000.00
•	FY 2008 SMS CIP Paving	\$150,000.00
•	FY 2010 Fort Hill CIP Paving	\$68,432.50
•	FY 2011 CIP Paving	<u>\$10,000.00</u>
•	Funds Available	\$578,432.50

Robertson Construction submitted a bid in the amount of \$577,980.00. The school division received only one bid for this project.

The contractor will start this project within the next three weeks. It will take at least four months to complete the project, but because of winter weather, there might be a break in the project. The project should be completed by spring 2012. Because all work is occurring on the outside of the building, there will be no impact on student instruction.

G. Acting Superintendent's Comments

Mr. Coleman provided the school board with information about the various summer programs which included Summer Safari for grades PreK - 5, summer enrichment programs, and summer athletic camps. He also stated that the SOL academies are finishing up and that testing would occur this week.

The school division has multiple capital projects underway which include the painting of interior and exterior areas on several different schools as well as work occurring to complete the installation of trailers at Sheffield Elementary School. Mr. Coleman announced that the Heritage High School gym floor project would be completed tomorrow, and that roofing work is almost completed at Hutcherson Early Learning Center.

The auditors will begin their work in the Department of Finance beginning August 15, 2011.

School board members have received a copy of the Teacher Level Professional Growth Handbook. This item will be discussed at the school board meeting on July 19, 2011.

H. Board Comments

Mr. Billingsly announced that the Heritage High School Task Force would meet on Friday at 1:00 p.m. Community members should be receiving surveys over the next few days.

Mrs. Barker announced that she had talked with members of city council about scheduling an informal gathering for city council and the school board. She will provide additional information regarding this event and she receives it.

Dr. Dolan-Sewell welcomed Ms. Poore to the school board. She also thanked all the school staff for the time they have given to provide enrichment and other summer activities for students.

Ms. Waller visited William Marvin Bass Elementary School and indicated that teachers are very excited about the beginning of their new school year.

Rev. Anderson congratulated Mr. White and Mrs. Tweedy on their appointments as chair and vice chair.

Mrs. Barker provided information about Mr. Webb's recent surgery and indicated that the surgery had gone well and that Mr. Webb was now at home.

The Superintendent's Evaluation Tool Committee met on June 28, 2011, and the committee hopes to provide a formal presentation to the school board at the meeting on July 19, 2011.

Mr. White thanked members of the school board for the opportunity to serve as chairman. He stated that they are a wonderful team and that the board is committed to moving the school division forward as a team. He also thanked Mrs. Barker for her service as chairman for the past two years recognizing that she has set a very high standard for him.

The Virginia School Boards Association has requested that the school board appoint a delegate and an alternate delegate as representatives during the annual convention. Mr. White and Mrs. Tweedy were appointed by the school board through consensus.
