D. Student Representative Comments

E-1. Superintendent Selection Process

Representatives of HYA have reported that there are 35 individuals who have applied for the superintendency for the Lynchburg City Schools. Mr. White announced that pursuant to the Code of Virginia §2.2-3712 (B), during the next 15 days the Lynchburg City School Board will hold closed meetings at undisclosed locations for the purpose of interviewing candidates for the position of superintendent.

E-2. Lynchburg City Schools' Comprehensive Plan 2011-12

The Standards of Quality require local school boards to adopt a division-wide comprehensive plan to improve classroom instruction and student achievement. The proposed Lynchburg City Schools' Comprehensive Plan 2011-12 includes goals and strategies organized around the school board's Vision for Education, adopted August 7, 2000. It includes all components required by the Standards of Quality. The plan was made available for public view on the Lynchburg City Schools' website, and an opportunity for public comment was provided through e-mail response at comprehensiveplan@lcsedu.net.

Dr. Sullivan provided a summary of the changes made to the plan as a result of the school board's discussion during its annual retreat. Those changes include the amendment of the summary statement on page 10 to more accurately reflect the intent of the objective. Changes to the summary statement on page 13 were made to provide a better idea of benchmark for reporting categories.

F-1. Legislative Positions: 2011-12
