A-1. Public Comments

Mr. Ronald Shavers spoke about his interactions with children who participate in his Kings and Queens Afterschool Program and their perception of teachers being unresponsive to their needs.

Mr. Robert Flood spoke about the inability of ex-felons to volunteer in schools.

Ms. Wendy Yates spoke on behalf of veteran teachers regarding the teacher pay scales.

Ms. Catherine Phillips spoke on behalf of the LEA regarding compensation for employees.

B-1. Governor's Award for Excellence and Innovation in Education

On October 26, 2017, Mrs. Karen S. Nelson, principal of Perrymont Elementary School, was presented with the Governor's Award for Excellence and Innovation in Education in the area of Closing the Achievement Gap. There were 13 recipients out of more than 120 nominations who received awards in five categories. The categories are: Closing the Achievement Gap, Community Partnerships and Collaboration, Innovation in Education, Preparing Students for the New Virginia Economy, and Supporting School Readiness.

The initiative recognizes outstanding educators and leaders, schools, divisions, and community partners across the five categories. Governor McAuliffe stated that, "Over the last four years, my administration has worked hard to reduce the achievement gap, improve accountability, expand opportunities for career exposure and experiential learning in our public schools. These individuals, schools, divisions, and partners are at the forefront of that effort..."

The school board recognized Mrs. Nelson with a plaque and a photograph of her and her staff with the governor.

C-1. Finance Report

The school administration, in accordance with the FY2017-18 school operating budget, authorized, approved, and processed the necessary payments through September 30, 2017. The school administration certifies that the amounts approved are within budgetary limits and revenue.

The operating fund expenditure report summarized the payments made through September 30, 2017 for the operating fund.

Mr. Beckles explained that revenues are on target for the three-month period. There are some negative balances in expenditures as the audit was just completed and accounts have not been closed from the 2016-17 school year.

Mr. Beckles gave an update of the students who receive free and reduced lunch indicating that all applications had been processed for all eligible students. Applications for new students who enroll in school and who are eligible for services are processed the same day. Meal participation for students is trending up. The School Nutrition department is having difficulty hiring qualified individuals to prepare and serve meals.

The finance module of the Alio software has been installed and is now operational. Phase 2 of the installation process will begin soon. This software is for personnel and payroll. This will take a little more time as Alio will need to be configured to interface with software used for employee leave and time-keeping.

H-1. Special Education Advisory Committee: 2017-18

State regulations governing the education of students with disabilities require the Lynchburg City School Board to appoint a Special Education Advisory Committee annually. This committee meets a minimum of four times per year. Members serve two-year terms.

The Virginia Department of Education guidelines define the role of the Special Education Advisory Committee as follows:

- To advise the school division of unmet needs in the education of students with disabilities;
- To assist the school division in the formulation and development of long-range plans designed to provide needed educational services for students with disabilities;
- To participate in the development of priorities and strategies for meeting the identified needs of students with disabilities;
- To submit periodic reports and recommendations regarding the education of students with disabilities to the division superintendent for transmission to the school board; and
- To assist the school division in interpreting plans to the community for meeting the special needs of students with disabilities.

H-2. Virginia Tiered Systems of Support Grant Cohort 4: Implementation Phase 2017-18

Lynchburg City Schools was awarded \$25,000.00 from The Virginia Department of Education (VDOE) for Cohort 4 of the Virginia Tiered Systems of Supports (VTSS) for the 2017-18 school year. The VTSS is a coordinated, tiered approach to improving educational outcomes through a continuum of evidence-based academic, behavioral, and mental wellness supports for all students. Through this initiative, the VDOE will provide training and technical assistance to Lynchburg City Schools with the implementation of VTSS, including the initial focus area of Positive Behavioral Interventions and Supports (PBIS). The pilot schools for VTSS coaching are E. C. Glass High School and Linkhorne Middle School.
