#### **C-1. Public Comments**

## **D-1. Pre-Kindergarten Program**

Mr. Michael K. Rudder, director of elementary education, provided information to the school board about the pre-kindergarten program. He explained that in 1994, the Virginia General Assembly appropriated \$10.3 million for the Virginia Pre-School Initiative (VPI), which would begin in 1996. Since that time, funding has gradually increased so that more at-risk four-year-olds could be served. In FY2011, \$60.5 million was allocated for this program.

The Virginia General Assembly uses a funding methodology which uses the estimated number of four-year-olds for Free Lunch as the proxy for at-risk four-year-olds. The estimated number of unserved at-risk four-year-olds is calculated by applying each locality's free lunch eligibility rate to the total estimated number of four-year-olds and subtracting the number of children being served by Head Start. State funding is provided based on the state share of \$6,000 per eligible child, minus the composite index. The local share is capped at 50 percent.

The VPI provides students with a quality preschool education, health services, social services, and incorporates parental involvement. Students must go through a screening process before they are accepted to the program.

## E-1. Finance Report

The school administration, in accordance with the 2011-12 school's operating budget, authorized, approved, and processed the necessary payments through November 30, 2011. The school administration certifies that the amounts approved are within budgetary limits and revenue.

The operating fund expenditure report summarizes the payments made through November 30, 2011, for the operating fund.

The city and the schools administration continue to meet regarding the consolidation of health benefits. Information was presented to the group by Livingwell Health Solutions so that the city could learn what services they are providing to school employees through helping them understand intervention and health management.

The composite index has increased to .3727, which will cost the school division about \$400,000. Federal stimulus funding ceases this year, therefore that \$2.5 million will no longer be available to the school division. Proposed increases to VRS could cost the school division \$5.8 million. Mr. Beckles suggested that the school board consider building a reserve each year to help with anticipated increases from here forward. The school administration is looking at an \$8.9 million deficit for the 2012-13 school operating budget.

Rev. Anderson announced that there would be a Finance Committee meeting on January 26, 2012, at 1:00 p.m. in Room 206 at the School Administration Building.

## I-1. Youth Risk Behavior Survey

In 1999, Lynchburg City Schools began conducting the Youth Risk Behavior Survey (YRBS) with students in sixth, ninth, and twelfth grades. The survey has been given every three years since 1999 and gathers

information about student health and risk taking behaviors. This year, 2011, is the year in which the student survey should be given. Over the years funding for this project has come from grant sources; however, grant funds for the 2011-12 survey are no longer available.

Central Virginia Health District/Virginia Department of Health currently has an Action Communities for Health, Innovation, and Environmental Change (ACHIEVE) grant which has funds available for the YRBS project. Since the funding is available, the team that guides the ACHIEVE project and the members of the School Health Advisory Board would like to see the YRBS conducted with sixth, ninth, and twelfth grade students during the second semester of the 2011-12 school year. The survey information has been vital to the community and the schools for the planning of prevention activities and programs.

Mrs. Bond-Gentry explained that students may opt out of the survey. The students who take the survey remain anonymous; however, there is a space within the survey that allows for students who are experiencing difficulty to identify themselves so that counselors and others can help with problems they might be having.

#### I-2. Intersection Improvements at memorial Avenue, Lakeside Drive, and Park Avenue

The City of Lynchburg's Department of Transportation Engineering is requesting acquisition of a temporary or permanent right-of-way of approximately 424 square feet/.01 acres at the southeast corner of the E. C. Glass High School property directly adjacent to the intersection of Memorial Avenue and Lakeside Drive. This right-of-way will accommodate a five-foot sidewalk that will connect to the existing sidewalk on Memorial Avenue. This request is due to the federally-funded Highway Safety Improvement Program project initiated by the city.

# I-3. Special Education Annual Plan/Park B. Flow-through Application and Section 619 Preschool Grant Applications: 2011-12

The Annual Special Education Plan is a formal agreement between the local school board and the Virginia Board of Education for the implementation of state and federal laws and regulations related to services mandated for students with disabilities. Accordingly, the disbursement of funds to the school division is contingent upon school board approval of the plan.

On May 17, 2011, the Lynchburg City Schools submitted the Special Education Annual Plan Part B Flow-through Application to the Virginia Department of Education. On November 4, 2011, Lynchburg City Schools received notification that the plan as submitted was approved and \$2,123,152 in federal funds were awarded. This award is \$31,890 below the anticipated grant award. Lynchburg City Schools also received notification that the Section 619 Preschool Funds for 2011-12 was approved, and \$62,014 in funds were awarded. This award is \$133 below the anticipated grant award.

The Virginia Department of Education requires the Lynchburg City Schools to submit a revised budget. Therefore, the attached proposed grant budget reflected revisions to the Part B Flow-through and Section 619 Preschool Grant.

The reduction in funding has created significant problems for school divisions across the Commonwealth as the reduction was not anticipated.

# I-8. High School Program of Studies: 2012-13

Each year modifications are made to the *High School Program of Studies* to reflect changes at the federal, state, or local level. This year's recommended changes are based on the following: significant student enrollment in Advanced Placement online courses, increased interest in career-technical programs, removal of career-technical courses no longer available, updating of some course descriptions, and the need for additional elective offerings. The recommended additions are in line with the following goals of the school division's Comprehensive Plan:

- Goal 4 of Academic Eminence: One hundred percent of high school graduates will have completed one of the following programs: college preparatory, career-technical education, or school-to-work."
- Goal 5 of Academic Eminence: "The school division will increase opportunities for students to develop higher levels of knowledge and skills in the core content areas and to explore and advance in elective, co-curricular, and extra-curricular offerings as well."

In addition, minor corrections and clarifications have been made in the program of studies. The attachment provided more detail regarding proposed new courses.

Further, the e2020 online provider for credit recovery and credit accrual is designed to help students stay on track for graduation. This program has allowed more students to enroll in Advanced Placement courses.

### J. Superintendent's Comments

Dr. Massie thanked staff for the presentations given to the school board this evening. He also thanked Mr. Gatzke for the extraordinary work performed by him and his crew last week on the electrical problems at Heritage High School.

Dr. Massie explained that the rough draft of the Request for Qualifications for Heritage High School has been completed and it will be delivered to the city's procurement office on December 7, 2011. The school board will be given a copy of the final document once it's completed.

The next City/Schools Leadership meeting will occur on January 9, 2012, at 8:00 a.m. at City Hall.

Dr. Massie announced that a committee has been formed to discuss the school division's student uniform policy. The committee, consisting of two parents, two principals, and Mr. Coleman, will meet next week.

Dr. Massie asked the school board permission to present the results of the efficiency study in March rather than January. Through consensus, the school board granted his request.

Dr. Massie announced that he is forming a Customer Service Committee. This committee will be charged with helping school division employees interact with parents and students more effectively.

# **K. Board Comments**

Rev. Anderson thanked colleagues on the school board for their support during the loss of his father. It was comforting to him to have that support.

Mr. Billingsly spoke with Mr. Comerford prior to the school board meeting and learned that the work occurring at Heritage High School to relieve the leaking is working as there were no major leaks during the past few rainy days.
